Treasurer's Report

Beth reviewed report. Revenue and expenses are less than expected for first 2 months. We are \$4,500 short of projected. We have \$130,000 in cash as of 9/9/14. We were expecting \$10,000 in sponsors but currently at \$2,500 for the time period. We opted not to do an expo at conference due to timing and waiting on a check from DPR, which can be attributed to the short fall.

2) ACTION UPDATES (5:40 PM)

Sponsorships & Finance

How much of our revenue came through large donations? SDG&E is our biggest sponsor thanks to Lucia. We have quite a number of small donors but the large donors \$5,000+ are important. Jacques suggested going back to previous sponsors such as Barona. Shooting for a board sponsorship of \$56,000-\$60,000 for fiscal year.

Currently, we have \$72,000 in grant funds with an additional \$22,575 based on likelihood of winning additional grants in which we have applied. Ocean Technology is a potential new opportunity, similar to Solatube, valued at approximately \$5,000 taking us to an estimated \$26,000. Other funding in grants is pending availability from SD Foundation and pending guidelines for Blue Water Project. National grant funding may or may not be available in 2014 as the program is currently on hold.

We are reviving finance committee. Doug agreed to serve as board liaison and appoint Jan Sachs as a co-chair based on her interest in fundraising.

ED Search: Approve Job Description/Schedule

Renee will be relocating to LA in January 2015 and has provided notice now to allow for a successful transition. Beth thanked Renee for her leadership most recently and for providing the time for a successful transition. Board members agreed.

We will be soliciting for a new ED with applications being accepted September 23-October 29, 2014 with selection of candidates by November 1, Interviews and Negotiations early November with a new ED in place by winter social or no later than the 1st of year. We have identified fundraising as a key skill for the new ED.

Board expressed interest in someone with green building and USGBC knowledge. The board indicated leadership and local relationships is vital. The board also indicated need to make it clear that fundraising is a key part of their role. Additionally, that national is changing the landscape of chapters and is eagerly pushing for consolidation in California and the rollout of an individual membership model.

Other things mentioned included the additional of a bonus plan, larger salary range, momentum of organization, and no relocation provided.
